Part VI, Question 2, Peter G. Hastings is the uncle of David R. Hastings III. Both Trustees are associated in one law firm. They were named as Trustee and Successor Trustee in the Trust instrument as confirmed by the Oxford County Probate Court, South Paris, Maine

Par VI, Question 11A. The form 990 is prepared by the governing body (the trustees) themselves.

Parv VI, Question 19. The governing document of the organization is on file and available to public inspections at Oxford County Probate Court, South Paris, Maine under Docket #61-91. The organization files financial reports annually with the same Court, and they are available for public inspection in the same docket Number. The Probate Court reviews and approves the accounting by the Trustees annually.
