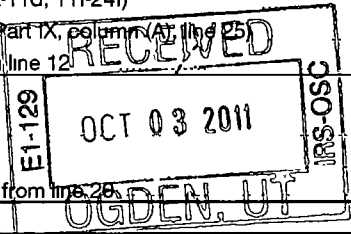

THE CONFERENCE WAS THE 97TH INTERNATIONAL EDUCATIONAL CONFERENCE PROVIDED AS AN EXCEPTIONAL PROGRAM FOR THOSE IN THE WORKFORCE DEVELOPMENT PROFESSION, AND THE PROGRAM CONTENT INCLUDED TOPICS SUCH AS POVERTY, EFFECTS OF GLOBAL RECESSION, VETERAN'S VOCATIONAL REHABILITATION, AND BENEFIT PAYMENT CONTROL BEST PRACTICES. THE CONFERENCE PROVIDED 16 HOURS OF EDUCATIONAL OPPORTUNITIES DIVIDED INTO GENERAL SESSIONS AND WORKSHOPS IN THE FOLLOWING FOUR TRACKS: WORKFORCE SERVICES, UNEMPLOYMENT SERVICES, VETERANS PROGRAMS, AND PROFESSIONAL GROWTH. THE CLEMSON UNIVERSITY PROVIDED ONE CONTINUING EDUCATION UNIT (CEU) FOR EVERY TEN CONTACT HOURS OR 1.65 CEUs FOR THE CONFERENCE.

THIS IS A SET OF STUDY GUIDES AND EXAMS TO TEST A MEMBER'S KNOWLEDGE OF THE WORKFORCE SYSTEM. THERE ARE FOUR DISCIPLINES COVERED IN THE RESOURCE GUIDES AND ACCOMPANYING EXAMS.
