Our mission is to provide financial support for and advice to Gethsemane Garden Christian Centre, a Christian boarding school in Western Kenya, which provides housing, clothing, food, and a quality education to almost 500 students (over 80% are orphans) from the Suba Tribe. The school is located on Mfangano Island in Lake Victoria.

During fiscal year 2010, the organization made grants of \$533,742 to Gethsemane Garden Christian Centre in Western Kenya. These grants were made possible through charitable donations from a donor base of over 400. The Christian boarding school has almost 500 students from Kindergarten through Grade 11. Grade 12 will be added in 2012 with the first class graduating in 2013. Grants in 2010 were made for both monthly operational expenses and capital expenses associated with the Lower and Upper Schools. A detailed listing of the grants and the uses is attached to this return. Our organization makes on-site visits to the Kenyan school on at least an annual (normally more often) basis and requires the Kenyan school to undergo an annual audit by a reputable CPA firm out of Nairobi, Kenya. Of particular note, the Upper School, which will house grades 9 - 12, is under construction with a projected completion date during 2011. The capital expenses associated with this construction project accounts for the increase in grants to the Kenya organization during 2010. The remaining \$3,847 in program expenses shown above were not in the form of direct grants but were expenditures by our organization for socks, shoes, and Community Health Evangelism outreach conducted through the school.

Accordingly, donations received at the banquet are shown in line 1f along with other donations received throughout the year
