	Shelburne Farms is a nonprofit education organization, 1,400 acre working farm and National Historic Landmark. The Farm offers learning experiences and resources for educators, schools, children and families for practicing sustainability in their communities. We collaborate with other regional, national and international organizations to advance education for sustainability. The Farm also serves as a catalyst and convener for strengthening local food, forestry and energy systems. In 2010 Shelburne Farms served over 145,000 program participants and visitors. Highlights for 2010 included: facilitating significant progress with Vermont's "farm-to-school" initiative with support from the Centers for Disease Control and Prevention, partnering with the Institute for Sustainable Communities on education for sustainability learning communities in Japan and China, and working with the Burlington School District on establishing the sustainability Academy at Lawrence Barnes School. The Academy is the first elementary magnet school with a sustainability theme in the country. On the Farm, special grants made possible food system improvements, a solar energy installation and additional major campus improvements, including structural repairs at the Breeding Barn, reconstruction at the Shelburne House gardens and construction of energy efficient Dairy employee housing.
