Learn to sail instruction to youth. The Center offers summer programs to youth of various age groups from 6 years old through High School, and for different experience levels. Students are enrolled individually, or attend as groups sponsored by local youth organizations including Spectrum Youth, New North End Youth Center, and the Greater Burlington YMCA. Students are taught the basics of sailing, water safety and group cooperation.

Learn to sail instruction to adults. Daytime and evening classes to adults who wish to learn to sail, or who wish to improve their sailing skills.

Boat storage and boat rental. The Center maintains a fleet of boats available for rental to persons who are already skilled at sailing. The Center also provides storage, space for individuals who wish to store their own boats and use The Center's facility to gain access to the lake. The Center is located near the city center, and is therefore accessible to the significant majority of the Burlington who wish to arrive on foot, by bicycle or by using public transportation if they choose.
