


Primary Exempt Purpose

The mission is to further an appreciation for the local downtown through support of business, organizations and schools; the writers, artists, music and theater; promotion of historic preservation and community beautification; and to assist in child and adult literacy.

Form 990-EZ: Line 28, Description

Part III, Line 28

The establishment of the Jim Mitchell Community Park, an open green space in the center of Warner's downtown. At least 3500 people directly benefit from the existence of the park, including the residents of Warner and surrounding towns. The park includes a Heritage Walkway, honoring the many individuals, families and organizations that have contributed to the history of the town.

The annual MainStreet Warner Literacy Program again brought a major author, this time National Poet Laureate Maxine Kumin, to speak with the children of the Simonds Elementary School. All 180 children from the school received an autographed copy of her bestselling childrens book, Mites to Mastodons.

Indoor space was provided for more than 150 events, averaging three per week, with attendance averaging between 20 and 30 people for each event. Examples of ongoing events include yoga and art classes, meditation and Tai Chi classes, a quilters guild and a spinners group, and bedtime reading to the children by the fire. Special events included such things as slide shows from the historical society, author appearances, live music, and art shows.
