INTRODUCTION: PURPOSES, GOALS, MEMBERS AND VOLUNTEERS

Purpose: The mission of the YMCA is to put Christian principles into action through programs that build healthy spirit, mind and body for all. YMCA programs focus on four core values: Caring, Honesty, Respect and Responsibility. We serve men, women and children of all ages, races, abilities, incomes and religions.

Goals: The goals of all YMCA programs and practices are to build strong kids, strong families and strong communities. YMCA's help people:

- Grow personally: Build self-esteem, self-reliance.
- Develop values for daily living: Develop moral and ethical behavior based on Judeo-Christian principles.
- Improve personal and family relations: Learn to care, communicate and cooperate with others close to them.
- Appreciate diversity: Respect people of different ages, abilities, incomes, races, religions, cultures and beliefs.
- Become leaders and supporters: Learn the give and take necessary to work toward the common good.
- Develop specific skills: Acquire new knowledge and ways to grow in spirit, mind and body.
- Have fun: Enjoy the good in all people, enjoy life.

Members: In the year 2010, 8,420 people were members of the YMCA, including 4,448 youth, 3,484 adults and 488 seniors. Fifteen percent of these members received financial assistance valued at \$90,184. In addition the YMCA served 3,427 people who participated in YMCA programs. Over 500 of these participants receive financial assistance valued at \$383,294. A total of \$473,478 in financial assistance was distributed in 2010, which is 14.41% of our operating budget.

Volunteers: In 2010, 22 policy making volunteers contributed over 600 volunteer hours of service to the YMCA, valued at \$7,200 based on \$12 per hour. Also in 2010, more than 400 program volunteers helped in YMCA programs for a total of over 2,300 hours valued at \$18,400 based on \$8 per hour.

PROGRAM DESCRIPTIONS AND SERVICE ACCOMPLISHMENTS

YMCA Aquatics: YMCA Aquatics programs are part of the YMCA's overall goal of building a healthy spirit, mind and body. In addition to providing specific water safety and skills development, the programs promote good health through regular exercise. They also promote leadership, self-confidence and teamwork. These programs are offered at a fee that is affordable to the community at large, with financial assistance for those who can't afford the full fee. With the areas many lakes, rivers and canals, aquatic safety among our residents is very important. In 2010, over 5,000 children were enrolled in YMCA aquatic classes and thousands were involved in free swim opportunities. The YMCA taught over 125 young adults to become certified in life saving and aquatic instruction. Nearly 250 adults, 150 of them seniors, were involved in a variety of aquatic and arthritic exercise classes. Many of these people are normally precluded from regular exercise programs due to physical restrictions. Over 7,000 different people, infants through seniors participated in aquatics classes and activities in 2010.

YMCA Health and Fitness: The familiar YMCA triangle emphasizes the oneness of spirit, mind and body. YMCA health and wellness programs help achieve the unity through medically based programs that stress proper exercise, nutrition, stress management and health education.

YMCA programs are designed to attract people of all ages, abilities, income levels and interest levels. The YMCA provides a homogeneous environment that is comfortable to all participants. The YMCA health and wellness program is truly a mirror of our community; all aspects of the community are integrated into one program interest area.

Collaborative efforts with 30 area health, welfare and agencies serving challenged and special needs clients broaden the YMCA health and fitness areas to include traditionally excluded populations. These and the more traditional populations benefit from the YMCA scholarship programs for financial assistance.

YMCA Family Life Programs: Strengthening families and meeting the needs of children have always been central to the YMCA mission of building healthy spirit, mind and bodies for all. The central focus of all YMCA preschool and school age childcare programs is to foster growth and development, not only in the children, but also in their parents and families. Accordingly, parents play an important role in policy and program decisions. YMCA child care curricula help children develop moral and ethical behavior, self esteem and leadership. YMCA child care allows parents to remain gainfully employed, knowing that their children are thriving in a safe environment under caring leadership. YMCA financial assistance policies help insure that children of lower economic levels are afforded the same child care opportunities as those able to afford the full fee. In 2010 there were more than 185 children each day, from over 20 area schools, serviced in YMCA before and after school programs. Many of those children receive YMCA financial assistance valued at over \$134,000. The YMCA preschool center serves 45 children each day, many of whom are also assisted financially, a total of \$90,812.

YMCA Family Life Programs (Cont.):

The YMCA is proud to be a family center. Families are able to take advantage of a safe, friendly environment with others of like interests. Family swims and recreational activities as well as parenting skills development are heavily attended by a broad range of families in our community. The YMCA plans activities that bring groups of families together to support and enjoy each other. The families have a chance to learn from each other and enjoy their children in an enjoyable way under caring leadership.

YMCA Camping: YMCA day camping, family camping and adventure camping develop self-confidence and respect for one another and the environment. Y camping programs are educational; they promote spiritual awareness, mental development, physical well being and social growth in the great out of doors. Through a variety of activities and the use of natural surroundings, YMCA camping seeks to help participants achieve their highest potential in spirit, mind and body. Affordable to most of the community, YMCA Camp Massapoag is available to over 700 campers each summer, a great opportunity for working parents to avail their children of a positive growth experience during the summer months. YMCA financial assistance programs assisted over 250 children from low-income families, area shelters and the Lowell Housing Authority with camp scholarships of almost \$58,531 in 2010. Two additional urban camps were run in Lowell servicing 125 kids per week. In these programs over \$99,000 was provided in financial assistance.

YMCA Youth Programs: YMCA teen leadership programs include YMCA Leaders Clubs and Counselors in Training. All teen programs are geared to give kids good role models that help them develop self esteem, good values, healthy life styles, and respect for themselves, others and the environment. Structured activities after school hours are vital to the safe and healthy development of teens in today's society.

Youth sports and recreation programs promote an appreciation of one's own self worth. YMCA youth sports focus on the full and equal participation of all; every child plays in every game. YMCA youth sports programs also strengthen families. Many of the parents volunteer in the leadership of the program and siblings participate or watch as family members play. Young people participating in sports develop lifelong positive attitudes, habits of healthy exercise and good nutrition. Adult relationships with youth are a vital part of all YMCA youth programming.

Youth Drop-In is a neighborhood program for inner-city youth. This program meets three nights per week all year through. The youth in this program are primarily Hispanic children from the Back Central neighborhood of Lowell. Many of them are from dysfunctional homes and desperately need the positive influence of the adult volunteers and staff who direct the program. Every child in this program is funded by the YMCA scholarship programs. The 2010 value of this subsidy amounted to over \$25,000.

Membership Dues and Assessments: The YMCA is a membership association of men, women and children dedicated to putting Christian principles into practice through programs that promote healthy life styles. YMCA membership is available to people of all ages, cultures, incomes, races and religions. Members have access to all YMCA programs free or at reduced rates. Many members are also contributors and many volunteer. Scholarships to members amounted to over \$98,184 in 2010.
