Membership: Through memberships, the HR YMCA pursues its goal of improving the health and well-being of the community and giving back and supporting our neighbors. We are 5572 members strong (as of December 31, 2010), and 8 percent receive financial assistance through our "Membership for All" program. Through membership, individuals and families in the Pioneer Valley have access to all of the Y's facilities and adult classes at no extra cost. The facilities available to members include our wellness floor with state-of-the-art cardio and weight lifting equipment, a separate free-weight room, a stretching room, a 6-lane, 25-yard indoor pool, a shallow, warm-water pool, a gym with basketball courts, a racquetball court, family locker rooms, and adult-only locker rooms with saunas and steam rooms. We also provide extensive childcare to help parents take advantage of our facilities. Members can work with our wellness staff through consultations or our Y-Connect program to tailor a fitness plan to help them meet their goals. Kids ages 9-15 can relax, play games, or workout in our Youth Lounge, and families can play in our Amaze Place playroom during Family Time. Members also participate in a wide range of fitness classes. In any week, they have approximately 70 group fitness classes to choose from, including yoga, cycling, muscle conditioning, cardio, boot camp, and classes for seniors. On summer weekends members can enjoy the Family Center at Camp Norwich, which includes a lake, beach, and 137 acres of woods and fields.

Programs: The HR YMCA offers a wide range of programs, primarily for youth, to members and non-members for a fee. Our instructors and coaches create a non-competitive and encouraging environment while promoting the YMCA core values of honesty, responsibility, caring, and respect. Our programs also create a place for families to meet friends and create supportive communities. Youth classes include dance, gymnastics, intro to sports, soccer, basketball, martial arts, and fitness training. Our aquatics programs include children as young as 6-months-old, and we offer group lessons as well as private. Kids who want to participate in team sports at the Y can choose from gymnastics, swimming, and basketball. Our swim and gymnastics teams participate in meets with other teams from around the region, while basketball is an intramural league, where teams are all from the HR YMCA. In 2010, 1326 youth participated in our aquatics programs, 829 in gym and dance, 428 in youth sports, and 72 on the gymnastic teams, and 156 on the swim team.

Camp Norwich: The HR YMCA offers the quintessential summer camp experience through Camp Norwich, available to both members and non-members. Located 20 minutes from the YMCA building, the facility encompasses 137 acres of lake, woods, and fields. Kids from kindergarten through 8th grade participate in one or two-week sessions from late June through late August. In 2010, total enrollment for all camp weeks was 987. Activities include swim lessons, canoeing and kayaking, archery, fishing, team sports, arts and crafts, drama and overnight campouts for older kids. Camp Norwich's mission is to help campers develop self-confidence, teamwork, an appreciation of the outdoors, creativity, and pride in themselves and their skills. Norwich also provides a Counselor in Training (CIT) program for youth entering grades 9 and 10, which helps them build excellent leadership skills. For parents, Norwich is a worry-free form of childcare. Our instructors are carefully hired and trained, camp lasts from 9:00 a.m. until 4:30 each weekday, and the Y provides from the main building. To make Norwich accessible to all families, the YMCA will adjust fees according to income.
