

Trail Maintenance - This involves keeping existing trails useable by cutting back brush, mowing paths in fields, removing and/or cutting up fallen trees. It also could involve creating new trails for non motorized use.

4b (Code:) (Expenses \$ 4,305 including grants of \$) (Revenue \$)
Educational Grant Expense - We co-funded a grant with the Buxford Elementary Schools Trust that created a customized natural educational program for second and fourth grade students in the Buxford schools incorporating writing skills and scientific exploration. Moss Audubon field teachers visited the Cole school in the fall and winter, leading students on field explorations that included the study of habitats and maple sugaring. In the springtime, the teachers visited the Spafford Pond school for a spring ecology program. This was a successful pilot program that now being funded through the schools. We also paid students to help with our trail maintenance.

4c (Code:) (Expenses \$ 3,656 including grants of \$) (Revenue \$ 7,094)
Event Expense - The main yearly event is the horse show. This involves riding competitions for all ages. Money is earned for BTA/BOCT by charging fees for entering each competition class. We also held a fall trail ride over some of the trails that we maintain. There is no charge for this event. We also held a children's pumpkin hunt on one of the properties we helped to preserve.
