	The Alliance’s policy work in 2010 resulted in an extension of the enhanced tax incentive for conservation easement, partly due to the recruitment of 274 House and 41 Senate cosponsors for legislation to make it permanent, including a majority of both Democratic and Republican members of the House We estimate this will increase the amount of acres protected in 2011 by at least 250,000 acres We also took a leadership role in organizing land trust support for America’s Great Outdoors, a major new land conservation initiative by the Administration that seeks to more effectively leverage the increased conservation funding requested in the fiscal year 2012 budget Lastly, we have closely coordinated work to prevent IRS audits from discouraging legitimate conservation donations We keep land trusts, landowners and attorneys abreast of changes in the law and in its implementation, and are actively educating IRS leadership and staff about conservation donations

	The Alliance’s Education and Capacity-Building Programs advance land conservation broadly and help land trusts improve their programs and prepare for accreditation A comprehensive curriculum was created based on Land Trust Standards and Practices with 490 copies sold or downloaded through the bookstore in 2010 In addition, 76 land trusts underwent guided organization assessments We presented 220 training workshops through our regional programs and national conference, plus 18 webinars that all together reached a total of more than 3,300 people, we continued to expand the online Learning Center where members can access online courses, search a digital library and join discussion forums that provide technical assistance We also awarded \$381,968 in grants and scholarships to land trusts

	The Conservation Defense Program provides networking, education and legal information to over 450 conservation attorneys and senior practitioners on conservation defense The Alliance collaborates with existing networks, services and experts in each state for this national information-sharing system The program gives land trusts ready access to the tools and resources necessary for conservation defense across the country through the Network, the Clearinghouse, the attorney locator, continuing legal education and phone-support problem solving As part of the multi-layered approach to conservation defense, the Alliance is creating a private insurance program controlled by and in business to serve its land trust members, we are promoting it to the land conservation community as a safety net for land trust defense reserves Adequately addressing multiple expensive conservation easement challenges, third party trespass or challenges to land owned by the land trust is difficult Everyone has some risk So far, land trusts have committed 150% of the necessary ‘units’ for this program to be feasible The Alliance is now raising the capital to satisfy the regulations and applying to various regulators to start the program
