Our June 7, 1993 tax exemption letter describes the Endowment as Exempt under Section 501(a) of the Tax Code as an "organization described in Section 501(c) 3". Since we are also an "organization described in Section 509(a) 3," we are not a private foundation. We have been treated as an organization supporting an old church and its congregation, which has been for four decades using the church rent-free. The Church and the Congregation both are represented on our Board, as are the trustees of an old trust which also maintains the Church.

In the undercroft, as well as congregational offices and meeting rooms, we maintain five crypts in which are buried the founder of the church and many of his family and descendants, and some friends including former ministers. These crypts remain in active use.

In 2010 we received a gift of \$15,000 from one Board member and a gift of \$10,000 from another, and a gift of \$4000 from the Church Trust. Since our insurance company, Church Mutual Insurance, prefers that the premium responsibility be placed on the Endowment, where in the past we have shared the responsibility; and since our accounts in any event were being moved; and because we have received an engineering report which expresses concern about the stonework masonry and parts of the roof; it seemed feasible to our Board, and that of the trust, to effectuate an exchange wherein certain income-bearing trust securities were shifted to our endowment, in exchange for an equivalent transfer of cash which was relocated as a Fabric Fund, to the trust.

We expect the Endowment to return to more modest and normal circumstances next year.
