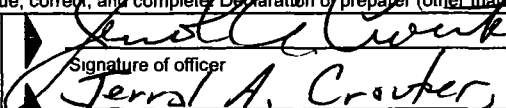

LITIGATION & OTHER ADVOCACY. Represents clients (individuals below 200% of the federal poverty level) before administrative agencies, the state legislature, and state and federal courts, primarily with regard to systemic issues related to food assistance, health care, income support programs, and housing and utility-related matters. MEJP handled over 500 cases in 2010, including administrative and legislative matters as well as direct client services. These included 169 cases regarding health care (primarily Medicaid related), 255 cases concerning food assistance and income support programs, 23 cases regarding housing and utility matters, and 11 cases dealing with consumer issues. MEJP also provided training and education on these issues throughout the state to over 500 service providers and advocates on issues and public benefit programs affecting people with low income.

MEJP was successful in 2010 in linking two education and training programs—the state's Competitive Skills Scholarship Program and the training component of the federal Food Supplement program (formerly known as food stamps), creating greater opportunities for low-wage workers to gain the skills they need in today's labor market.

HEALTH CARE. In conjunction with the representation noted in 4a, performs legal research and public policy analysis, and develops strategies to improve access to health care for low-income individuals and families at the state level. Specific state activities include protecting and improving access to health care for over 290,000 Medicaid enrollees and improving prescription drug coverage for approximately 86,000 low-income seniors and people with disabilities.

4c (Code) (Expenses \$ 170,437 including grants of \$ 7,500) (Revenue \$ 0)

TANF and Parents as Scholars. In conjunction with the representation noted in 4a, performs legal research and public policy analysis, and develops strategies to improve Temporary Assistance to Needy Families (TANF)—Maine's public benefit program, including opportunities for higher education and training so that participants can secure employment and achieve economic security. Specific activities include sustaining benefits for over 14,000 families receiving TANF, including 25,000 children, and close to 700 Parents as Scholars participants, as well as improving benefits for those transitioning into the workforce.

Maine Equal Justice conducted a comprehensive study of families who participate in Maine's TANF program in 2010. Through an extensive survey sent to 8,700 families and subsequent focus groups, MEJP sought to better understand the reasons that families seek assistance and the obstacles they face in today's economy. The findings will guide public policy recommendations at the state and federal levels.
