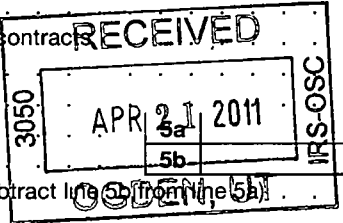

The organization's primary exempt purpose is "to engage in charitable activities in less developed nations...in pursuit of lasting beneficial advancement for those countries [which] may include education, economic development, and support of Christian institutions. It may also respond to compelling needs for assistance in the areas of food, shelter and medical care."

To that end, (1) the grants noted in Part III of Form 990-EZ were distributed; and (2) personal work was undertaken, resource people were mobilized from the United States, and Nepali leaders were trained and supported to (a) develop and expand the operations of a new model elementary school in the town of Trishuli, Nepal through teacher training, organizational development, and financial support; and (b) provide vocational support and guidance to young men and women who have "graduated" from the supportive home run by Prison Fellowship Nepal. The first of these "graduates" has now completed a bachelor in business college degree. Travel for this work was paid by the expenses noted in line 16 of Part 1.
