To help rural communities in the Mara Region of Tanzania achieve a higher quality of life by promoting simple, natural solutions to poverty, hunger and disease. We fund programs in water resource development, permaculture, solar cooking, herbal medicine and support for orphans

Global Resource Alliance funds the drilling of hardrock boreholes to provide clean, safe water to rural villages. Much of the expense for 2010 went for equipment repairs, drilling accessories and personnel costs for organizations in Tanzania performing the work, travel expenses for consulting volunteers and interest on debt incurred to purchase hand pumps.

4b (Code:) (Expenses \$ 117,438 including grants of \$ 91,363) (Revenue \$ 22,250)

Global Resource Alliance provides funding for a permaculture (organic agriculture) project in Kinesi Village that employs and trains 12 local villagers who are growing food for all the families in the village who support orphans. There are a total of 12 acres under cultivation at present. We also fund a tree planting project that trains villagers to plant and care for trees and have distributed over 50,000 trees to villagers at no cost.

4c (Code:) (Expenses \$ 35,119 including grants of \$ 33,025) (Revenue \$ 22,390)

Global Resource Alliance provides funding for several different orphans support programs. One project supports 75 orphans in Musoma Town who receive food supplements for their foster families, soap, school supplies, healthcare and school tuition through high school. Another project in Kinesi Village supports all orphans in the village needing assistance with similar benefits. A third program provides one hot meal per day and educational services for 200 nursery school age kids.
