The foundation makes grants to agencies in Bridgeport, CT to help fund after-school programs, homelessness prevention and resettlement citizenship initiatives

The nearly 120 students in Charter Oaks scholarship program are among Bridgeports finest. They have excelled academically and contributed significantly to their communities despite tremendous financial and personal hardships. Each of the 15 students accepted annually into the program receives a \$10,000 scholarship over four years and a trained mentor. The use of mentors, combined with the escalating payout structure of the scholarship funds, helps ensure that Charter Oak Scholars will remain in school through graduation. The results have been staggering. Charter Oaks retention rate is 95 percent nearly four times the 25 percent graduation rate among all Bridgeport students who go to college.
