Set-asides totaling \$8,000 were made in the form of four CDs of \$2000 each, maturing in August of 2010, 2011, 2012, and 2013, respectively. As each CD matures, the bank verifies the enrollment status of each grantee. The principle is then disbursed by the bank, as instructed, to the two grantees in amounts of \$1000 each. The disbursements are deposited by the bank into the college accounts of the grantees. Interest earned by the CDs is retained for future scholarship awards.

No additional set-asides are planned for these specific students, although future awards to other grantees will also be made in similar set-asides.

Set-asides are used in order to assure that scholarship funds are disbursed over the four-year span of the students' college programs. Disbursing the entire amount in a single year would negate the fund's ability to assure the students' participation in four-year degree programs, which is part of the fund's purpose.

These CDs are set up with the US Bank in Mill City, Oregon. The bank is instructed, at the time the CDs are purchased, to distribute the CD principles, upon maturity, to the designated grantees in the designated amounts. Prior to each annual disbursement, the bank verifies the enrollment status of each grantee. Since the grants are for a period of four years, all grants to a given individual will be disbursed within 60 months.

CD for \$2000, maturing 8/24/2010. Disbursements of \$1000 to Chris Hale and \$1000 to Nick Johnston, made 8/24/2010. Nick Johnston did not use his grant, and it was returned to the Fund bank account, where it will be used for future grants.

CD for \$2000, maturing 8/24/2011. Disbursements of \$1000 to be made to Chris Hale and \$1000 to Nick Johnston, on about 8/24/2011.
