Guidelines and Scholarship Application

1. The Dede Emerson Foundation Scholarship Program was established to give scholarships to deserving high school students seeking a higher education.
2. Scholarships are awarded for undergraduate full- or part-time study preferably in veterinary work or international affairs.
3. The amount of the scholarship is \$1,000 given once a year to any one student. Said amount will normally be given to the Board of Education for redistribution to the college on behalf of the recipient in the following manner: 50% (fifty percent) upon entry to college and 50% (fifty percent) upon achievement of satisfactory grades, defined C or above.
4. All applicants must be officially accepted into an accredited school in the United States and in need of financial assistance. The Scholarship Committee shall determine said need.
5. Applicants must reside in the Greater Grand Rapids, Minnesota, school district.
6. The scholarship does not cover study at the masters or doctoral level or correspondence courses.
7. The Scholarship Committee shall consist of two or three representatives from the Dede Emerson Foundation plus two or three representatives chosen by the Board of Education.
8. The Scholarship Committee will meet during May to make its selection; therefore, the deadline for completed applications and all supporting materials is May 1st. No fax applications will be accepted.
9. Primary criteria for the scholarship is demonstrated scholastic ability and financial need.
10. Prospective applicants will be contacted by the Scholarship Committee for an interview if necessary.
11. Applications are available through the Grand Rapids High School counselors' office.
