THE MISSION OF THE SEVENTH REGIMENT ARMORY CONSERVANCY, INC (THE "CONSERVANCY") IS TO RESTORE, RENOVATE AND REVITALIZE THE HISTORIC LANDMARK PARK AVENUE ARMORY AS A CONTEMPORARY ARTS INSTITUTION WHOSE PROGRAMMING USES THE VAST SPACE OF ITS DRILL HALL AND THE ARRAY OF MAGNIFICENT PERIOD ROOMS TO PRESENT VISUAL AND PERFORMING ARTS THAT RESIST THE CONFINES OF FORMAL PROSCENIUM HALLS AND WHITE-BOX GALLERIES THE CONSERVANCY IS DEDICATED TO WEAVING THE ARMORY BACK INTO THE FABRIC OF NEW YORK CITY AS A CENTER FOR CULTURE, INNOVATION AND LEARNING, FILLING A CRUCIAL NICHE IN THE CULTURAL LANDSCAPE OF THE CITY

PARK AVENUE ARMORY IS A NOT-FOR-PROFIT INSTITUTION WHOSE MISSION IS TO REVITALIZE ONE OF AMERICA'S HISTORIC TREASURES AS A DYNAMIC ALTERNATIVE ARTS SPACE UNLIKE ANY OTHER IN NEW YORK 2010 WAS AN UNPRECEDENTED AND EXHILARATING YEAR FOR ARTISTIC PROGRAMMING AS THE ARMORY PRESENTED WORK IN THE VISUAL AND PERFORMING ARTS THAT OTHERWISE COULD NOT BE PRESENTED IN NEW YORK THE SOLD-OUT PERFORMANCES AND HIGH ATTENDANCE, AS WELL AS THE OVERWHELMINGLY POSITIVE RESPONSE BY ARTISTS AND VISITORS, CONFIRMED THE ARMORY'S IMPORTANT ROLE IN PRESENTING WORK THAT COULD NOT OTHERWISE BE REALIZED IN A TRADITIONAL MUSEUM SETTING AMONG THE HIGHLIGHTS ARTISTIC PROGRAMMING DURING THE SPRING, THE ARMORY PRESENTED ITS SECOND ANNUAL VISUAL ARTS COMMISSION, ENTITLED NO MAN'S LAND, A SITE-SPECIFIC INSTALLATION BY ARTIST CHRISTIAN BOLTANSKI DESCRIBED AS "STUNNING" BY THE NEW YORK TIMES AND WHAT VIEWERS THEMSELVES CALLED HAUNTING, TRANSFORMING, POIGNANT, AND MONUMENTAL NO MAN'S LAND WAS A COMPANION PIECE TO PERSONNES, AN INSTALLATION AT THE GRAND PALAIS IN PARIS THAT OPENED IN JANUARY 2010, AND THE ARMORY'S FIRST MAJOR INTERNATIONAL PARTNERSHIP IT WAS BOLTANSKI'S LARGEST AND MOST AMBITIOUS WORK TO DATE IN THE UNITED STATES AND COULD NOT HAVE BEEN REALIZED ANYWHERE ELSE IN NEW YORK CITY ANCILLARY PROGRAMMING INCLUDED AN ARTIST TALK BETWEEN BOLTANSKI AND NOTED AUTHOR AND CRITIC LUC SANTE THAT DREW A STANDING-ROOM ONLY CROWD, A SPECIAL INSTALLATION OF ARTISTS' BOOKS CREATED BY CHRISTIAN BOLTANSKI AND CURATED BY MICHAL JACHULA, AND A FILM SCREENING OF LES VIES POSSIBLES DE CHRSTIAN BOLTANSKI, A 52-MINUTE DOCUMENTARY FILM ABOUT BOLTANSKI A SITE-SPECIFIC MUSICAL EVENT INSPIRED BY NO MAN'S LAND, ENTITLED DAWN, COMPOSED BY FRANCK KRAWCZYK, WAS PERFORMED BY MEMBERS OF THE ACCLAIMED ARGENTO CHAMBER ENSEMBLE WITHIN AND AROUND THE DRILL HALL AND THE INSTALLATION, RECONFIRMING THE ABILITY OF THE ARMORY'S FLEXIBLE, OPEN SPACE TO FOSTER GROUNDBREAKING COLLABORATION BETWEEN MULTIPLE DISCIPLINES NO MAN'S LAND RECEIVED EXTENSIVE COVERAGE IN THE PRESS, INCLUDING NEARLY 100 PLACEMENTS IN A RANGE OF PRINT, BROADCAST, AND ONLINE OUTLETS- FROM MAJOR DAILY NEWSPAPERS TO TOP CULTURAL BLOGS POTENTIAL PRINT REACH TOALED OVER 11 MILLION AND WEB CIRCULATION OVER 123 MILLION IN TOTAL, MORE THAN 7,700 PEOPLE VISITED THE INSTALLATION DURING ITS MONTH-LONG RUN USER SURVEYS SHOWED THAT NEARLY ONE THIRD OF VISITORS SPENT MORE THAN AN HOUR CONTEMPLATING, CONNECTING WITH AND BECOMING A PART OF THE WORK, MANY RECORDING THEIR OWN HEARBEATS FOR BOLTNASKI'S ARCHIVES DU COEUR THE ARMORY CONTRIBUTED 1,853 HEART BEATS TO BOLTANSKI'S ARCHIVE PROJECT IN THE FALL, THE ARMORY ANNOUCED ITS FIRST FULL ARTISITC SEASON FOR THE 2010-2011 YEAR THE FIRST PROGRAM WAS THE SPECTACULAR OF THE UPPER PART OF THE DRILL HALL, INSTALLING NEW WINDOWS, REPAIRING THE ROOF, REINFORCING THE STRUCTURE, INSTALLING NEW HEATING, AND ADDING STATE-OF-THE-ART PRODUCTION EQUIPMENT THAT ALLOWS PRODUCTIONS TO BE PRESENTED IN A COST-EFFICIENT WAY THE ARMORY ALSO COMPLETED THE REHABILITATION AND CLEANING OF THE LEXINGTON AVENUE FACADE FINALLY, THE ARMORY BEGAN THE RESTORATION OF THE FIRST TWO HISTORIC ROOMS AS A PILOT PROJECT WORKING IWTH ARTISANS AND CONSERVATORS, THE ARMORY HAS BEEN ABLE TO DETERMINE THE TECHNIQUES NEEDED TO PEEL BACK THE HISTORIC LAYERS AND PRESERVE THE PATINA FROM THE PAST 130 YEARS, WHILE ALSO REMOVING THE OVER VARNISH ON THE WOODWORK TO REVEAL THE ORIGINAL FINISH APPLIED IN 1880 EDUCATIONAL PROGRAMMING THE ARMORY HIRED ITS FIRST EDUCATION DIRECTOR TO DEVELOP ITS PROGRAM WITH THREE STRANDS PRODCUTION-BASED EDUCATIONAL PROGRAMMING, WHICH INTRODUCES NYC PUBLIC SCHOOL STUDENTS TO THE ARMORY'S UNCONVENTIONAL ART, IS LED BY THE ARMORY'S CORPS OF TEACHING ARTISTS AND HAS SERVED MORE THAN 2,500 CHILDREN TO DATE A PRESERVATION-BASED CURRICULUM WAS PILOTED IN 2010 WITH THE WILLIAMSBURG HIGH SCHOOL FOR ARCHITECTURE AND DESIGN, USING THE ARMORY AS A TOUCH-STONE FOR THE SCHOOL'S CURRICULUM FINALLY, A YOUTH CORPS PROVIDES A STRUCTURED AND MENTORED AFTER-SCHOOL WORK EXPERIENCE IN THE ARTS FOR AT-RISK HIGH-SCHOOLERS 13 STUDENTS HAVE PARTICIPATED IN THE PROGRAM SINCE IT LAUNCHED IN THE SPRING OF 2010, GIVING THESE PROMISING YOUNG PEOPLE A BETTER CHANCE AT SUCCESS AND A GREATER AWARENESS OF THEIR OWN POTENTIAL HISTORY AND PRESERVATION A TEAM OF SPECIALISTS COMPLETED THE CATALOGING OF THE ARMORY'S SIGNIFICANT COLLECTION OF FURNITURE, PAINTINGS, SCULPTURE, SILVER, AND OTHER DECORATIVE OBJECTS THE MALKIN LECTURES CONTINUED IN THE FALL WITH WILLIAM GRIMES SPEAKING ON APPETITE CITY A CULINARY HISTORY OF NEW YORK CITY AND CURATOR JASON BUSCH ON INVENTING THE MODERN WORLD DECORATING ARTS AT WORLD'S FAIRS 1851-1939
