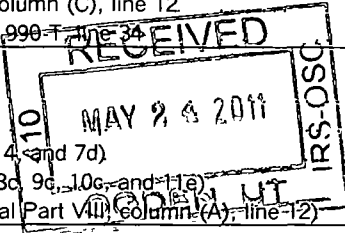

The Foundation and mtvU partnered to develop a Peabody Award-winning and Emmy-nominated social awareness campaign that uses on-air PSAs and programming, an online resource center (www.halfopus.com) and on-campus events, to raise awareness about the prevalence of emotional disorders on college campuses and connect students with the appropriate resources to get help. The campaign reaches more than 750 campuses and 90 million households.

4b (Code:) (Expenses \$ 157,762. including grants of \$) (Revenue \$)

The Foundation is committed to helping campuses best address the needs of at-risk students. As part of this effort, the Foundation is committed to training many different segments of the campus community to identify and address signs of distress or suicide. Training programs for health professionals, coaching staff and religious leaders on campuses have been launched or are in development. The Foundation also hosted and funded a series of regional Assessing and Managing Suicide Risk (AMSR) workshops that trained nearly 1,000 mental health professionals on assessing and managing suicide risk.

4c (Code:) (Expenses \$ 150,253. including grants of \$) (Revenue \$)

Ulifeline is an anonymous, confidential, online resource center where college students can be comfortable searching for the information they need and want regarding mental health and suicide prevention. The site includes information, interactive features, a screening tool and access to campus-specific resources for getting help. The site also includes Counseling Central, an area designed exclusively for college mental health and student affairs professionals. Currently, more than 1,500 colleges and universities participate in the Ulifeline network free of charge.
