AS STATED IN ITS MISSION STATEMENT THE LIBRARY'S PURPOSE IS "TO PROMOTE KNOWLEDGE, UNDERSTANDING AND APPRECIATION OF LITERATURE." IT ACCOMPLISHES THIS PROGRAM SERVICE BY PURCHASING BOOKS, MAGAZINES, NEWSPAPERS, AUDIO AND VIDEO RECORDINGS, AND PROVIDING COMPUTER TERMINALS FOR INTERNET ACCESS.
