A narrative is definitely called for in our situation. I will try to briefly explain the company's situation.

In 2008 the founder of the DVO gave the general management position over to another person but continued to handle what she considered the more important jobs such as taxes and financial records. In 2009 the founder became ill and in the spring on 2010 she died. No one had handled the financial and tax situation except her so no one had any idea of how the financial records, tax forms etc were done or where they were kept. We have tried in earnest for the past 11 months to piece together an accurate financial history of 2010.

In addition, the 2010 season was managed by two new individuals who, unfortunately had much less knowledge and experience than the board was led to believe and mismanaged the season badly so much so that one of the two operas produced never opened. None of the financial responsibilities were attended to and the death of Mrs. Krause, our founder, made the situation critical.

I was asked to be general manager of the company in November of 2010 and spent last winter piecing together the 2010 season. However I don't have any knowledge nor have I found the resources yet to be able to piece together the company's financial history of 2009 and before. In this effort I learned from my discussions with very helpful people at the IRS that the DVO's 2009 income tax form was never filed. Therefore I have no records of 2009 to refer to in trying to fill out this form.

The DVO enjoyed a very successful opera season this past summer (2011) and is strong artistically and in complying with its artistic and community missions. And we are confident that these past several years of organizational and financial mismanagement are behind us. Financial records and responsibilities are now being handled accurately.
