Industry/Education Outreach - KansasBio's primary function is to serve as the voice of the bioscience community in Kansas. In performing this function, we conduct formal and informal educational outreach activities. These activities are broken into two service areas:

a. Students - KansasBio sponsors scholarships and awards for students at the high school, undergraduate and graduate levels. KansasBio establishes and maintains partnerships with local school and universities to conduct poster award programs. These programs are the Kansas BioGENEius Challenge, the K-INBRE Undergraduate Awards, and the Capitol Graduate Research Summit Awards. Within each program, industry judges interview students, analyze student research projects, review

Industry Promotion - KansasBio serves as the voice of the bioscience community in Kansas by representing our bioscience industry at conventions and to the legislature. In 2010, KansasBio coordinated and participated in an industry presence at major conventions including the annual conference of the Biotechnology Industry Organization (BIO), DIA Annual Meeting, and AdvaMed. In addition, KansasBio sponsored three legislative tours for elected officials, a day-on-the-hill in Topeka and four bioscience industry luncheons in Topeka.

a. In 2010, KansasBio interacted with more than 930 people at conventions and conferences.

Community Outreach - KansasBio served as the voice of the bioscience community by hosting public educational outreach in communities across Kansas, as well as distributing regular and periodic updates via electronic newsletters and a printed publication. For example, KansasBio worked with the Kansas Department of Commerce, industry companies, and economic development partners to conduct 'Hot Team Meetings' in eight Kansas communities over a ten-week period. These meetings were focused on distributing results of a bioscience industry survey of the needed skills and competencies among area bioscience companies, as well as collecting information about local resources that could be used to support these companies' needs. Another program run by KansasBio is 'Hot Topics in Science,' in which industry professionals
