New England School of Metalwork maintains a strong relationship with The American Bladesmithing Society. NESM has been granted certification to our Auburn facility. We are only the third location in the entire United States to offer certified ABS training. Our classroom building offers limited dorm rooms with a kitchen facility. We have a state of the art foundry that supports our Casting Program, offering workshops in iron and bronze casting. We have approval status with the Veterans Administration through the University of Maine Department of Education. We have grant approval by the Maine Department of Labor for use in career centers and the Workforce Investment Act.
