The Learning Lamp offers high quality child care for families of all income levels. Its programs are licensed through the PA Department of Public Welfare and the PA Department of Education, ensuring they meet the highest health, safety and education standards. During the 2010-11 school year, its programs for young children and school-age students reached 625 children across three counties. Its summer programs for preschool, school-age and middle school students served an additional 400 children. Many of the students receive scholarship support or state-funded child care subsidy assistance to help fund tuition.

4b (Code) (Expenses \$ **566,499** including grants of \$) (Revenue \$ **615,760**)

The Learning Lamp engages K-12 struggling learners in individual and small group tutoring. Sessions are conducted by certified teachers during the school day or outside of traditional school hours. Materials are consistent with each school district's curriculum. The program is designed to build math and reading skills that are essential to school success.

The Learning Lamp works in partnership with schools across Pennsylvania to provide alternative education and transition classrooms and dropout prevention programs for students who are at risk for school failure. These programs provide a highly supportive, small group instructional setting with a counseling component. They are designed to help students resolve issues, earn credits and stay on track for high school graduation.
