Community Organizing and Civic Engagement: OneAmerica works to build power in diverse ethnic communities in collaboration with key allies. We do this through identification of and action on key issues that affect immigrants. We bring immigrants together with the mainstream public and provide opportunities to work for the common good and effect systemic change. Our 2010 priority issue areas included immigration reform, immigrant integration, racial profiling and general human rights. We educate, mobilize and engage immigrants, identify strong leaders, and develop their skills and abilities. We also help immigrants to understand and participate in the democratic process. In 2010, we embarked on several projects related to immigrant integration including: working with a subcommittee of the Governor's New Americans Policy Council to discuss and design ways to move forward a project that would increase access to English language learning through technology; working with the newly formed National Partnership for New Americans on an integration agenda; and beginning work on education reform and immigrants in the K-12 system. We also continued our successful Washington New Americans program, in partnership with the American Immigration Lawyers Association, which provides access to citizenship services for legal permanent residents who are eligible through state and private funding. We expanded our organizing base through establishing nine community base groups in several places across the state, helping immigrants to identify issues of concern to them and then working to educate and build leadership in immigrant communities across the state. Our Immigrants Day at the Capitol in early 2010 helped to engage over 250 immigrants in our democratic process and help introduce immigrants to their legislators and vice-versa.

Policy, Research and Communications: In 2010, OneAmerica worked to ensure broad access to accurate information and deeper understanding of issues through educating policymakers about issues affecting immigrants and refugees and educating community members about policy that affects their communities. We convened and led the Washington Immigration Reform Coalition table, with over 80 groups as partners in the coalition. We also continued to serve in leadership roles on national coalitions, including the Rights Working Group and the Fair Immigration Reform Movement of the Center for Community Change. We provided key fact sheets based on substantiated research through our website and provided policy makers and reporters with necessary information on key issues. In all of our work, we utilize communications tools-both social media and traditional media outlets-in English and other languages to reach immigrant communities and to inform the public.
