35 children orphaned from AIDS have been helped through our assisting Mavuno Village, an NGO in Tanzania, through their foster homes & providing food & education with farming & dairy projects.

175+ physically and mentally disabled children benefit from the learning & therapy programs and extra caregivers we provide in 2 government orphanages in Vinnitsa Oblast, Ukraine

Countless children in families, orphanages, & a children's cancer hospital have benefited from various local Dr's, youth teams, beauticians & others as that are able to minister to children as we provide the funding & information needed.

CFK has also assisted US schools & individuals in developing gardens, mailing birthday cards, distributing individualize gift bags, providing eye examinations & new glasses, & numerous other one on one projects directed to children.

Over 5,000 lbs of clothing, diapers & other supplies have been gathered, cleaned, & shipped for distribution through local churches, NGOs, & other volunteers who work with children in orphanages & need families in Ukraine and Tanzania.

Funds are provided for a Ukraine foster family caring for 10 orphaned children in Ukraine & an orphanage in Liberia.
