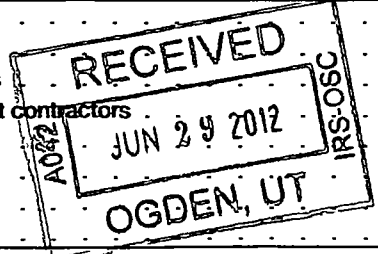



Publishers and authors DONATE Books to The Reading Tub Inc. We get them to literacy and educational non-profits (501c3, Schools, Title I Schools) working directly with at-risk readers.

Read Aloud Virginia Inc did that within the Richmond School System in 2010. We donated 158 books valued at \$1,575.07 (cover price).

We do not claim the books as income nor inventory. We warehouse them for distribution. The only cost is postage to ship them outside our 25-mile travel radius.

We have filled out Schedule A for years 2007 to 2009, the years this return assesses. See 990-N records for years 2007, 2008, 2009 ... and 2011.
