The Foundation did not sell any portion of these 6,000 shares of the Fairchild Semiconductor common stock, and at the close of the Foundation's current tax year (12/31/2010), the Foundation continued to hold these shares of stock, and an adjustment needs to be made in Part III (Analysis of Changes in Net Assets or Fund Balances) to reflect the difference between the date of gift value for these retained stock and the Foundation's book value for such stocks using the Donor's cost tax basis. The balance sheet adjustment for the donated stock is \$85,230.00 based upon the above fair market value and Donor cost basis figures. The net adjustment to the Changes in Net Assets or Fund Balances reflected on Line 5 of Part III is a decrease of \$69,557.00 (the above adjustment of \$85,230.00 plus adjustments for dollar rounding and other book value adjustments reported by the Foundation's investment advisor relating to its year end financial report).
