Our mission is to serve any group that has been marginalized from full participation in their country's social, economic and political life

We train women from the former displaced persons camps of northern Uganda in a micro-enterprise initiative that is providing them with a source of sustainable income. We currently have 90 women in the program. The project involves the creation of paper bead jewelry which Voices for Global Change, through its Paper to Pearls initiative, sells in the United States and throughout the world. The women are also trained in savings and cash management and thus learn the principles of micro-finance.

4b (Code:) (Expenses \$ 27,350 including grants of \$ 12,000) (Revenue \$ 29,135)

Voices for Global Change raises money in support of an orphanage in Takeo, Cambodia which provides for the well-being and education of 125 children and teenagers. Our funding also provides the opportunity for the Takeo orphans to go on to college or vocational school. This year, for the first time, we also made a significant donation to the Acodo Orphanage in Siem Reap, Cambodia.
