	IN 2010, HAGAR USA LED A CAPACITY-BUILDING PROJECT IN AFGHANISTAN THAT INCLUDED COALITION BUILDING AND EDUCATING MINISTRIES OF THE GOVERNMENT AND OTHER NON-GOVERNMENTAL ORGANIZATIONS ABOUT HUMAN TRAFFICKING ISSUES. IN ADDITION, THE PROJECT IS AIDING SHELTERS THAT ARE SERVING TRAFFICKING VICTIMS IN AFGHANISTAN TO INCREASE THEIR STANDARD OF CARE. IN 2010, HAGAR USA ALSO PROVIDED COMMUNITY-BASED FOSTER CARE TO A TOTAL OF 90 CHILDREN IN 39 DIFFERENT CAMBODIAN FAMILIES. THIS PROJECT PROVIDES A NURTURING HOME WITH TRAINED AND LOVING FOSTER PARENTS TO ABUSED CHILDREN WHO HAVE HEALED FROM THEIR INITIAL TRAUMA BUT HAVE NO SAFE, BIOLOGICAL FAMILY TO WHOM THEY CAN RETURN. ADDITIONALLY, IN 2010, 79 GIRLS FROM BACKGROUNDS OF SEXUAL ABUSE AND TRAFFICKING RECEIVED INTENSIVE TRAUMA SERVICES IN A SPECIALIZED RECOVERY CENTER. SERVICES INCLUDED COUNSELING, MEDICAL CARE, LEGAL SUPPORT, SPIRITUAL NURTURING, AND EDUCATION. IN 2010, HAGAR USA ALSO SUPPORTED THE CONSTRUCTION OF A NEW SHELTER IN PHNOM PENH, CAMBODIA FOR WOMEN FROM BACKGROUNDS OF EXTREME TRAUMA AND TRAFFICKING. THE REINTEGRATION OF TRAFFICKED WOMEN SHELTER WILL PROVIDE LONG-TERM CARE FOR 25 WOMEN AND UP TO 35 OF THEIR CHILDREN UPON COMPLETION.
