

Smoky Bear Days Chainsaw carving event and Smokey Bear Days are each held once a year in May. These events promote the awareness of Smokey Bear's fire prevention message and raise funds to assist Smokey Bear Historical Park. The Fun Run takes place once a year in July and it also promotes the awareness of Smokey Bear's fire prevention message and raises funds to assist Smokey Bear Historical Park.

The Association sells T-shirts and Smokey Bear souvenirs that resulted in a gross profit of \$2,753.71 in 2010.
