Impact for Jesus is a non-denominational resource platform serving individuals, communities, and the world through financial support, leadership development, and church planting in the name of Jesus Christ. We facilitate ongoing relationships between financial givers and receivers. Our most recent activity has been in facilitating relationships in Haiti, particularly after the earthquake. We were involved in the reconstruction of a church and orphanage with which we had an ongoing relationship.

The Grace House of Hope in Bon Repos, Haiti with which we have been working with since 2006, suffered substantial damage from the Jan 12, 2010 earthquake in Haiti. The church and orphanage collapsed. We mobilized many work teams from the US to go to Haiti on many occasions to help in the demolition and rubble removal as well as the rebuilding of the church and orphanage. We helped the Haitian people recover through the financing of the demolition and reconstruction of the church and orphanage.

Fostering our relationships in Haiti we were involved in the financial support of post earthquake relief projects and assisting with a financial contribution to the building of a medical clinic in Ganther region. This is being done through Lazarus Project/Village of Hope.

We further established our relationship with World Harvest/New Life 4 Kids in Haiti by funding the shipment of a container to them in Port au Prince Haiti to be used by them and other people in need in the area.
