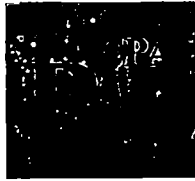

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

NATURE OF OPERATIONS

Mission E4, Inc. is a not-for-profit organization which mission is to train, equip and unify believers and ministries both locally and internationally. The organization operates a global training center in Hubbardston, Massachusetts, two schools and an orphanage in Haiti, and a school in Albania. It also makes mission trips to Haiti, Albania, Kosovo and Mozambique as necessary. Heavenly Minded Home Services, Inc. is a for-profit company providing home repair and maintenance services in the local Hubbardston, Massachusetts area.

ORGANIZATION

Mission E4, Inc. was incorporated in 2005 under Section 501(c)(3) of the Internal Revenue Code, in the Commonwealth of Massachusetts under General Law Chapter 180. Heavenly Minded Home Services, Inc. was incorporated in 2008 in the Commonwealth of Massachusetts.

FINANCIAL STATEMENT PRESENTATION

The financial statement presentation follows the Financial Accounting Standards Board in its Statement of Financial Accounting Standards (SFAS) No. 117, "Financial Statements of Not-for-Profit Organizations". Under SFAS No. 117, Mission E4, Inc. and Heavenly Minded Home Services, Inc. are required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, which represent the expendable resources that are available for operations at management's discretion; temporarily restricted net assets and permanently restricted net assets. The Organization presently has no temporarily restricted and no permanently restricted net assets.

BASIS OF ACCOUNTING

The books and records of the Organization are maintained on the accrual basis of accounting. Under the accrual basis of accounting, revenues are recorded as earned and expenses are recorded at the time liabilities are accrued.

PRINCIPLES OF CONSOLIDATION

The accompanying consolidating and consolidated financial statements include the accounts of Mission E4, Inc. and Heavenly Minded Home Services, Inc. Significant intercompany transactions and balances have been eliminated in consolidation. The Organization has a 60% ownership in the subsidiary, Heavenly Minded Home Services, Inc. Collectively the entities are referred to as "the Organization" throughout these footnotes.

CLASSIFICATION AND REPORTING OF NET ASSETS

The Organization classifies its net assets into three net asset categories according to donor-imposed restrictions. A description of the three net asset categories follows:

Unrestricted net assets represent the portion of the net assets of the Organization that is neither permanently restricted nor temporarily restricted by donor-imposed stipulations. All of the Organization's net assets are unrestricted.

The Organization has no temporarily restricted net assets, which represent contributions and other inflows of assets whose use by the Organization is limited by donor-imposed stipulations that either expire by passage of time or can be fulfilled and removed by actions of the Organization pursuant to those stipulations.

The Organization also has no permanently restricted net assets, which represent contributions and other inflows of assets whose use by the Organization is limited by donor-imposed stipulations that neither expire by passage of time nor can be fulfilled or otherwise removed by actions of the Organization.

IN-KIND CONTRIBUTIONS

Volunteers, throughout the Organization, donate time to the Mission E4, Inc. These program services are not included in the consolidating and consolidated financial statements since it is impossible to estimate the time and value of these services.

CASH AND CASH EQUIVALENTS

For the purposes of the statement of cash flow, the Organization considers all liquid investments with an original maturity of three months or less to be cash equivalents.

DONATIONS/ACCOUNTS RECEIVABLE

Donations/Accounts receivable are considered by management to be fully collectible and accordingly no allowance for doubtful accounts is considered necessary.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

PROPERTY, PLANT, AND EQUIPMENT

Property and equipment are recorded at cost. Depreciation is provided using the straight line and accelerated methods over the estimated useful lives of the assets. Repairs and maintenance are expensed as incurred.

INCOME TAX STATUS

The Mission E4, Inc. is a not-for-profit organization and accordingly is exempt from income tax under Section 501(c)(3). Contributions to the not-for-profit organization qualify for the charitable contribution deduction.

Heavenly Minded Home Services, Inc. is organized as a taxable for-profit company. Income taxes are provided at the applicable rates on income for financial reporting purposes.

Heavenly Minded Home Services, Inc.'s income tax filings are subject to audit by various taxing authorities. The Company's open audit periods are 2008-2009. In evaluating the Company's tax provisions and accruals, future taxable income, and the reversal of temporary differences, interpretations and tax planning strategies are considered. The Company believes their estimates are appropriate based on current facts and circumstances.

Deferred income taxes are required to be computed on the liability method and deferred tax assets are recognized only when realization is certain for temporary differences between financial statement income and tax return income. The principal temporary differences arise from the Heavenly Minded Home Services, Inc. charitable contributions which are limited by tax regulations. A deferred tax asset of \$4,017 has been recognized by the Company. As it is the intent of the Company to continue to make contributions above the maximum amount allowed by tax regulations to Mission E4, Inc., a reserve against the deferred asset of \$4,017 has not been recorded since such deferred tax asset is not expected to be utilized.

EXPENSE ALLOCATIONS

The costs of providing various programs have been summarized on a functional basis in the Statement of Activities and in the Notes to Consolidating Financial Statements. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

USE OF ESTIMATES

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting year. Actual amounts could differ from those estimates.

FAIR VALUE OF FINANCIAL INSTRUMENTS

The fair value of a financial instrument, such as accounts receivable and accounts payable, represents the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced sale or liquidation. Significant differences can arise between the fair value and carrying value and carrying amounts of financial instruments that are recorded at historical cost amounts. The Organization believes that the carrying amounts of cash and cash equivalents, accounts receivable and accounts payable approximate fair value due to their short-term nature.

2. PROPERTY, PLANT AND EQUIPMENT

On December 28, 2010, the Organization purchased land and buildings in Hubbardston, Massachusetts for \$1,388,800. In connection with the purchase, the organization has incurred 3 mortgages secured by the property in the amount of \$1,094,512.

In addition, the Organization has a holdback of \$170,000 for repairs/upgrades to be made by the seller by June 28, 2011 for 2 septic systems that did not pass Title 5 certification. As of the date of these financial statements, the repairs are not complete.

The Organization also invested \$138,000 in buildings and building improvements in Haiti during 2010.

6. COMMITMENTS

The Organization has agreed to work with Straight Ahead Ministries, Inc., a Massachusetts Corporation, on the establishment and operation of the Worcester Youth Center outreach program. Under this agreement, the organization will provide \$294,000 of funding for the program over a five year period. Five payments of \$50,000 are due annually beginning on December 1, 2011. The final payment of \$44,000 will be due on December 1, 2016.
