Water First International provides grants to non-governmental organizations (NGOs) based in developing countries in order to support the implementation of projects that include provision of drinking water, hygiene education, and sanitary latrines The Organization works with NGOs in some of the poorest communities in the world to support sustainable, community-managed solutions to water supply and sanitation problems During 2010, the Organization and the local NGOs completed 105 water systems in four countries, benefiting over 12,000 people The Organization has completed a total of 430 water systems benefiting over 52,000 people since inception In addition, the Organization initiated projects in Ethiopia and Honduras that will benefit about 5,000 people upon completion in 2011
