Eight volunteer participants in western Ecuador assisted in collecting data on more than 750 animals, including 5 apparent new species. Thousands of data points were taken and continue to be analyzed to produce and disseminate information to managers to make informed conservation decisions. Results were reported to the Ecuadorian government and are also reported at www.ReptilesandAmphibians.org. Photographs and information on new and rare species were published world-wide in scientific journals and general media.
