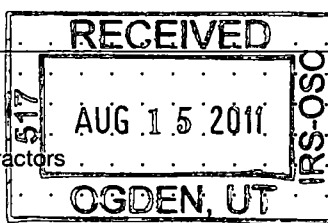

Part III, Line 29: Scholarships- Eighteen scholarships for continued education in the regional universities and technological institutes. The

The scholars came from the following communities - 5 from Chijnaya, 4 from Tuni Requena, 4 from Tuni Grande, 5 from

Coarita.

Volunteer Program - The foundation supported 2 American student volunteers who taught English and worked on other projects in Chijnaya and other surrounding communities benefiting approximately 150 local village students.

Libraries - This year we completed the installation of the library in the district of Callalli, Arequipa, Peru, serving a population of approximately 5,000.

Publications - The foundation supported and contributed to the expenses for the publication of 2 volumes of Andean ethnographic studies dealing with the cultures of the area where the foundation operates. We also co-sponsored the publication of a volume on Applied Anthropology in Peru in both Spanish and English editions.

Part III, Line 30: The foundation assisted the artisan association of Chijnaya with the promotion of its artisan products. The foundation

sponsored the associations participation in the 2010 International Folk Art Market in Santa Fe, New Mexico. A total of

We also monitored the loan funds in our communities from which additional loans were made in each of those

communities for new sheds.
