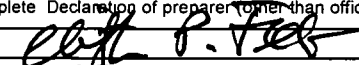
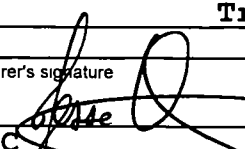

The IWC trains trusted immigrant leaders to become resource connectors in local immigrant communities and links them with the myriad of social services. Our volunteers also provide emotional support and faster integration of the foreign-born by serving as mentors, thereby building the self-sufficiency of people facing significant language and cultural barriers to accessing critical needs.

In 2010, the IWC:

- 1) Assisted nearly 1,600 vulnerable immigrant and refugee women, men, and children in accessing help; the most common request for assistance was in finding employment.
- 2) Re-developed the Level 1 training program and manual utilizing seven local training professionals with expertise in multicultural communities to update our core, 24-hour training program for new Natural Helpers.
