In 2010, we offered ongoing long-term residential care to eleven residents. We provided long-term ongoing support to two individuals (former residents) who are living in clinics or institutions through conducting weekly therapeutic visits. We built the capacity of our staff and provided ongoing training to them to ensure that we are providing quality and holistic care to our residents. Training topics in 2010 included Crisis Management, Behavior Management Plans and Grant-writing. In 2010, nine of our residents were able to attend a local university for a special education degree-granting program. Additionally, we continued our in-home programs to encourage the social, physical, mental and vocational well-being of our residents. Through these weekly programs, we facilitated community and societal integration. Individual Care Plans, which include data from the International Classification of Functioning, Disability and Health, continued to serve our residents and provide quantifiable data in regard to the growth and development of our residents.

The cost of operating the group home in 2010 was \$91,144. This includes \$60,020 which was wire transferred to Jermik Ankyun Foundation in Armenia as reported in Part II, Line 1 as a grant as well as \$5,830 in cash contributions originating in Armenia and deposited directly to the Jermik Ankyun Foundation. The \$65,850 is monitored through daily correspondence between the Executive Director of Friends of Warm Hearth, Inc. and the Country Director of Jermik Ankyun Foundation in Armenia, which provides support and control of the funds. In addition, onsite visits are conducted on an annual to bi-annual basis (a visit was made in 2010) and a comparison is made of budgeted versus actual expenditures with explanations of significant variances. Quarterly accounting reports are submitted to Friends of Warm Hearth with budgeted versus actual expenses. Lastly, the budget and expenditures are reviewed by the full Board of Directors.
