In 2010, the education department provided services to 53 students, providing 6,037.75 hours of instruction. One student earned his high school diploma. Two students passed admittance tests. Twelve students were supported in attending higher education classes. The average progress students achieved in attending 6 months of tutoring in reading was an increase of 1.5 grade levels, an increase of 10 words per minute in reading speed, a 1% increase in word accuracy, and an increase in comprehension of 8.7%. The library at Scenicview increased the number of checkouts by 1800%. Scenicview held a school-wide teacher training for 12 of the instructors at Scenicview. One staff member presented on Adult Autism Spectrum Disorders at a national Learning Disabilities Association conference. Scenicview received Nation Commission for the Accreditation of Special Education Services.

The mission of clinical services is to provide opportunities for individuals with learning disabilities to increase emotional, social, and cognitive skills that lead to a more successful independent life. Clinical services provides individual and group psychotherapy, psychological testing and recreational therapy services. In 2010, animal-assisted therapy was introduced in a classroom setting and was coordinated with the Animal Assisted Therapy Association of Utah. Group therapy and recreation therapy services were combined in team building activities. Recreation therapy services were augmented with the inclusion of programming targeted at small groups, similar interest groups and individuals. The recreation therapy staff developed and carried out the first annual overnight camp experience for the entire staff and student body. A new discharge summary form was implemented. A Clinical Unit Services report was created, which defines all the specific services the unit provides. Staff explored, researched, and were trained on several new modalities of treatment philosophies.

Scenicview Academy's case management department provided 11,747 hours of direct service to students in 2010. Scenicview currently has 8 case managers with a social service worker license or a license that exceeds the SSW scope of service. Scenicview hired 12 student drivers to provide transportation to students and staff to free up hours of case managers. These student drivers provided 2,583 hours of transportation, an increase of 729 hours over 2009. Scenicview continued to provide personal care services to a student with a higher level of disability. This student was moved to a facility more appropriate to his needs in December 2010.
