


The Foundation requires the students to maintain a 3.25 GPA to receive another year of the scholarships and attendance as full time students. The Foundation receives regular reports from Nebraska Wesleyan University's offices of academic affairs and scholarship and financial aid, including requiring the students to report to these offices and the Foundation of their progress and continued eligibility for the scholarships. The officers of the Foundation also meet several times with the scholars and communicate via e-mail and telephone individually as well.

For the NWU-Tartu Educational Exchange program, the University provides reports of expenditures on a regular basis. In addition, there is an executive committee of the Project with officers of NWU and the Foundation as members. This Executive Committee meets via conference call monthly to monitor the Program's progress and expenditures. Budgets on an annual basis are approved and expenditures outside of the budget must be pre-approved by the Executive Committee. See the Project Brochure attached to Part III page 2 Question 4b.
