

WE MATCH U.S. SPONSORS WITH CHILDREN IN NAIROBY KENYA FOR EDUCATION/SUPPORT. SPONSORSHIP COVERS COSTS FOR THE CHILD'S TUITION, UNIFORM, BOOKS, SHOES, LUNCH EACH DAY, AND BASIC HEALTH CARE. ALL U.S. ACTIVITIES HAVE BEEN PERFORMED BY VOLUNTEERS SINCE INCEPTION IN 2006.

WE SPONSORED 60 CHILDREN FOR THE SCHOOL YEAR BEGINNING IN JANUARY, 2007 AND WERE ABLE TO DOUBLE THAT WITH AN ADDITIONAL 60 CHILDREN SPONSORED FOR THE MAY 2007 TERM.
