Micro Church Planting. Our main service as an organization is to help initiate and grow micro churches reaching different groups of people in the city. In 2010 we expanded to plant micro churches in Hamburg, Germany and San Francisco, CA as part of the Underground Network. Also, there was work done to expand in Manila, Philippines and Haiti. These small churches provide many services to people in our community in need. They range from small fellowships that meet in people's homes to more wholistic ministries like providing care and housing for women seeking to leave the sex industry or young teenagers aging out of the foster care system. We provide ongoing training and equipping for the leaders of these small churches as well as provide the overall structure for them to exist and operate within the Underground Network.

Catalyst program. It is a weekly gathering of between 400 to 500 people. The service provides a place for empowerment, equipping, and encouragement to all leaders of the micro churches that are formed under our network. In addition, it serves as a time of envisioning new initiatives that could be started to reach different places in our city and around the world.

Ministry Center. This program expense provides for a multi-use classroom and office space for many of the small ministries and micro churches.
