These organizations care for the most vulnerable children in their communities. These children have lost one or both parents and are living in areas with high HIV/AIDS rates and/or are living in war zones. Lahash facilitated sponsorships for 80 children in Tanzania, 45 in Uganda, and 20 in Kenya (total of 145 children). These grants provided school fees, spiritual education, food, shelter, and clothing for the children.**4b** (Code: N/A) (Expenses \$ 22,722 including grants of \$ 0) (Revenue \$ 0)Travel Expenses - Lahash alerts, trains, and facilitates volunteers to our partner locations across East Africa. These volunteers learn about the local problems and solutions in the region as well as provide professional services in the fields of medicine, journalism, Christian education, finances, staff development, photography, and social services. In 2010 Lahash facilitated the trips for fourteen volunteers. These volunteers cared for an estimated 200 children in short term projects in connection with our partners.**4c** (Code: N/A) (Expenses \$ 13,366 including grants of \$ 0) (Revenue \$ 0)Publication and Media Expenses - Lahash advocates for vulnerable populations that have little or no global exposure to their plight. Our primary vehicle is a bi-monthly magazine that reaches 1000 readers. We also host and maintain ten websites and held six awareness events during the past year. Our online short documentaries have been viewed by over twenty thousand people.**4d** Other program services.
