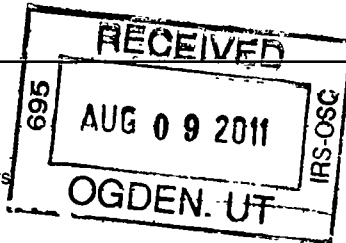

Three low-income participants received hands-on training and experience building an organic production garden from the ground up. They were empowered to plan, plant, and care for fresh food that they then brought home for their families and donated to other people in need. They reported that their eating habits improved as a result of their participation, and they felt they had gained the skills to grow their own vegetables at home. In total, we donated approximately 250 pounds of fresh produce to the food pantry during the season.
