SEACHANGE IS HELPING OUTSTANDING NONPROFITS RAISE SIGNIFICANT AMOUNTS OF FUNDING THROUGH PHILANTHROPIC CONTRIBUTIONS. THE FIRM IS WORKING IN THE FIELDS OF EDUCATION AND YOUTH DEVELOPMENT FOR LOW-INCOME YOUNG PEOPLE IN THE UNITED STATES FROM ITS LAUNCH IN JUNE 2006 THROUGH DECEMBER 2008, SEACHANGE CONCENTRATED ON CAPITALIZING ITSELF WITH FIVE YEARS OF OPERATING FUNDS IN ADVANCE OF BEGINNING ITS PROGRAMMATIC AND GRANT-MAKING ACTIVITIES SO THAT LATER IT WOULD NOT HAVE TO SIMULTANEOUSLY RAISE FUNDS FOR ITSELF WHILE ARRANGING FUNDINGS FOR OTHER NONPROFIT ORGANIZATIONS. DURING THE FIRST HALF OF 2008, IT RECRUITED A TEAM AND BEGAN TO IDENTIFY HIGH PERFORMING NONPROFITS WHILE ALSO CONTINUING TO BUILD ITS NETWORK OF POTENTIAL PARTICIPANTS FOR FUTURE FUNDINGS. DURING 2009, 2010 AND THE FIRST QUARTER OF 2011, SEACHANGE ARRANGED A TOTAL OF \$12.115 MILLION IN FUNDINGS FOR THREE ORGANIZATIONS: UNCOMMON SCHOOLS, THE NEW TEACHER CENTER AND COLLEGE SUMMIT. SEACHANGE ALSO COMMITTED \$1.0 MILLION TO NEW PROFIT, INC, FOR ITS PATHWAYS FUND APPLICATION TO THE SOCIAL INNOVATION FUND. IN CONJUNCTION WITH THIS GRANT, SEACHANGE TOOK ON THE ROLE OF COORDINATING CERTAIN ACTIVITIES FOR A FUNDING GROUP LED BY NEW PROFIT, AND INCLUDING THE BLUE RIDGE FOUNDATION, THE CARNEGIE CORPORATION, THE JPMORGAN CHASE FOUNDATION, THE OPEN SOCIETY FOUNDATIONS AND THE ROBIN HOOD FOUNDATION IN ADDITION TO SEACHANGE. THE GROUP CAME TOGETHER TO FUND A PORTFOLIO OF NONPROFIT ORGANIZATIONS INCLUDING COLLEGE SUMMIT, IMENTOR, YEAR UP, NATIONAL COLLEGE ADVISING CORPS, SINGLE STOP AND YOUTHBUILD USA.
