The Vail Snow Sports Foundation was formed for the educational and charitable purposes of supporting other 501(c)(3) charitable

organizations engaged in the support and advancement of youth skiing in the Vail Valley of Colorado.

The Vail Snow Sports Foundation provided grants totaling \$83,357 to Ski and Snowboard Club Vail, Brooke Wales (\$2,000), and Colby Lange (\$5,000) for the advancement and training of youth skiing programs in the Vail Valley of Colorado.
