### **World Caring Neighbor Foundation grantees, grant amount and activities:**

**2.1.1. Program - \$1000** (Program with the United Way of Lansing) provides assistance to individuals and families who call 211 due to need of shelter, food, medicine, clothing or for some other welfare crisis.

**Loaves and Fishes of Lansing - \$1000** shelters 275 (200 children) and provides 6,000 meals.

**SIREN of Charlotte - \$1000** shelters 475 including 230 children and provides 19,000 meals.

**GLEAM of Grand Ledge - \$600** provides assistance for food, shelter or medicine for 1200 adults and 900 children

**Child and Family Services - \$500** provides foster care, special needs adoption support services, transitional living services, mental health counseling, substance abuse treatment services, pregnant teen care, child abuse prevention services, and truancy reduction. These services are available to those in need in the greater Lansing area.

**Heart and Hands of Eaton Rapids - \$300** provides food for 111,450 meals to 2088 adults and 1627 children.

**Resolution Restorative Justice Center - \$300** (Program within the Restorative Justice Agency) works largely in Michigan schools to resolve antagonisms resulting from bullying, misunderstandings or ongoing conflicts among students.

**Tri-County Alcohol Awareness Committee (TCAAC) - \$300**, on behalf of TCAAC, the CNF sponsored a student essay/poem contest centered on the theme 'Stay Cool, Stay Sober'. The aim of the contest was to raise awareness among students attending Tri-County schools about the dangers of drugs/alcohol.

**Grand Ledge Alliance - \$1000** provides training on substance abuse to all athletes in the Grand Ledge School District.
