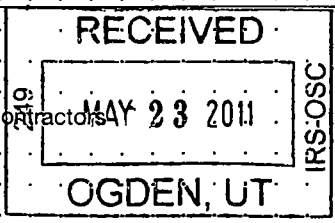



Part 1, line 8: This is income from rental of movie equipment assets acquired for our own movie production which was also rented out to other parties. It is not clear to me if this is "unrelated" business income as referred to in Part IV, line 35(a), and a form 990-T filing would not seem to apply, instead this income was also reported on our 1120-POL for this year.

Part 1, line 16: Other expenses this year were primarily movie production expenses (see Part 3, line 29) including asset acquisition of movie production equipment, which now are listed as a net asset (see below). Also included are expenses for provision of our internet servers and some small office and general expenses.

Part 2, line 25: Other assets in the previous year were hard asset investments which were sold in the current year for the gross profit reported on line 4 of Part 1. Other assets in the current year are the movie production equipment referred to above.
