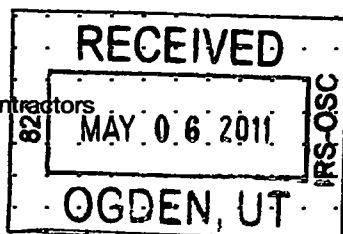

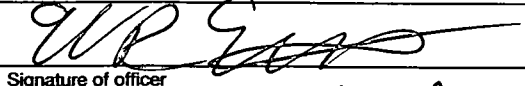

Soccer teams are formed and games are played in accordance with the rules stated by the Arkansas State Soccer Association during the fall and spring months. In the summer a soccer camp is held as well for community youths.
