Chances for Children helps support orphanages in Haiti which provide care for orphaned and abandoned children. This includes the support of schools and education initiatives as well as working with local nonprofit groups to expand the community where orphanages are located. This is accomplished by funding the construction of schools, providing child sponsorship, creating a fresh water supply and implementing vocational training and community based agricultural projects. In 2010 \$215,517 of expenses were incurred to support the Creche de l'Enfant Jesus orphanage in Ti Mache, Haiti. These expenses included \$50,551 of grants and \$58,260 of supplies that went directly to the orphanage to help support their operations as well as \$19,762 of donated food, medical supplies and educational supplies. An additional grant of

Chances for Children helps support the adoption process of children under the care of orphanages in Haiti by interfacing with the general public and adoption agencies who represent families who are interested in international adoption. In 2010 \$94,432 of expenses were incurred to assist with the adoptions of children from the Creche de l'Enfant Jesus orphanage in Ti Mache, Haiti. These expenses included legal fees, travel expenses, meals, lodging, postage & shipping, printing & publications as well as wages and payroll costs for the organization's staff who helped with the adoptions. Chances for Children helped complete 20 adoptions in 2010.

Chances for Children helps support schools and education initiatives serving the needs of children and young adults in select communities throughout Haiti. In 2010 Chances for Children made a grant of \$70,000 to the Coalition of Children in Need Association which is the U.S. partner for the Insitute Univers located in Ouanaminthe, Haiti. This grant provided scholarships for 350 students displaced in the earthquake. Chances for Children also provided a \$5,100 scholarship for two Haitian high school students to attend Georgetown College in the United States. An additional grant of \$35,000 was made to the Haiti Renewal Fund which is committed to the long-term rebuilding and revitalization of Haiti. The \$35,000 was received back in the form of a matching donation of \$70,000 from the National Christian Foundation.

2. Each month Chances for Children wires to Creche de I'Enfant Jesus the funds needed to run the orphanage (based on the budget from step 1) that month.

3. At the end of each month Creche de I'Enfant Jesus sends Chances for Children a monthly expense and income (grants received) report that details the money they received and the money they spent. In addition we receive reports on each child being adopted at the end of the adoption. This report shows all of the legal fees that were paid by Creche de I'Enfant Jesus to complete the adoption. Part of the Adoption Fee is used to pay for these expenses. The remainder of the adoption fee is used to help subsidize the monthly costs of running the orphanage and caring for the children.

4. On each visit to Haiti we review the financial components with them and learn of changes, the need for capital improvements, supplies, etc.

This includes the support of schools and education initiatives as well as working with local nonprofit groups to expand the community where orphanages are located. This is accomplished by funding the construction of schools, providing child sponsorship, creating a fresh water supply and implementing vocational training and community based agricultural projects. In 2010 \$215,517 of expenses were incurred to support the Creche de l'Enfant Jesus orphanage in Ti Mache, Haiti. These expenses included \$50,551 of grants and \$58,260 of supplies that went directly to the orphanage to help support their operations as well as \$19,762 of donated food, medical supplies and educational supplies.
